Terms of Reference

- 1. To set directions for LIFE and ensure that it is in congruence with the directions of the University;
- 2. To consider financial budgets for consolidation into the overall University's budget;
- 3. To consider and endorse new programme proposals and major initiatives/programme changes proposed by LIFE;
- 4. To monitor quality assurance and academic standards of programmes and courses offered by LIFE, including endorsement of policies and guidelines, approval of minor programme changes, overseeing teaching, learning and assessment, approval of student progression and discontinuation, and appointment of External Academic Advisers;
- 5. To consider and endorse recommendations of the Examination Committee on the award classification of students and conferment of award of Associate Degree, Higher Diploma and Diploma for the approval of the Undergraduate Examinations Board under the delegated authority of the Senate; and approve the graduation and award classification (if any) for other academic awards offered by LIFE;
- 6. To receive annual reports of LIFE and approve annual programme reports; and
- 7. To set up committees, task forces and working groups as necessary.
